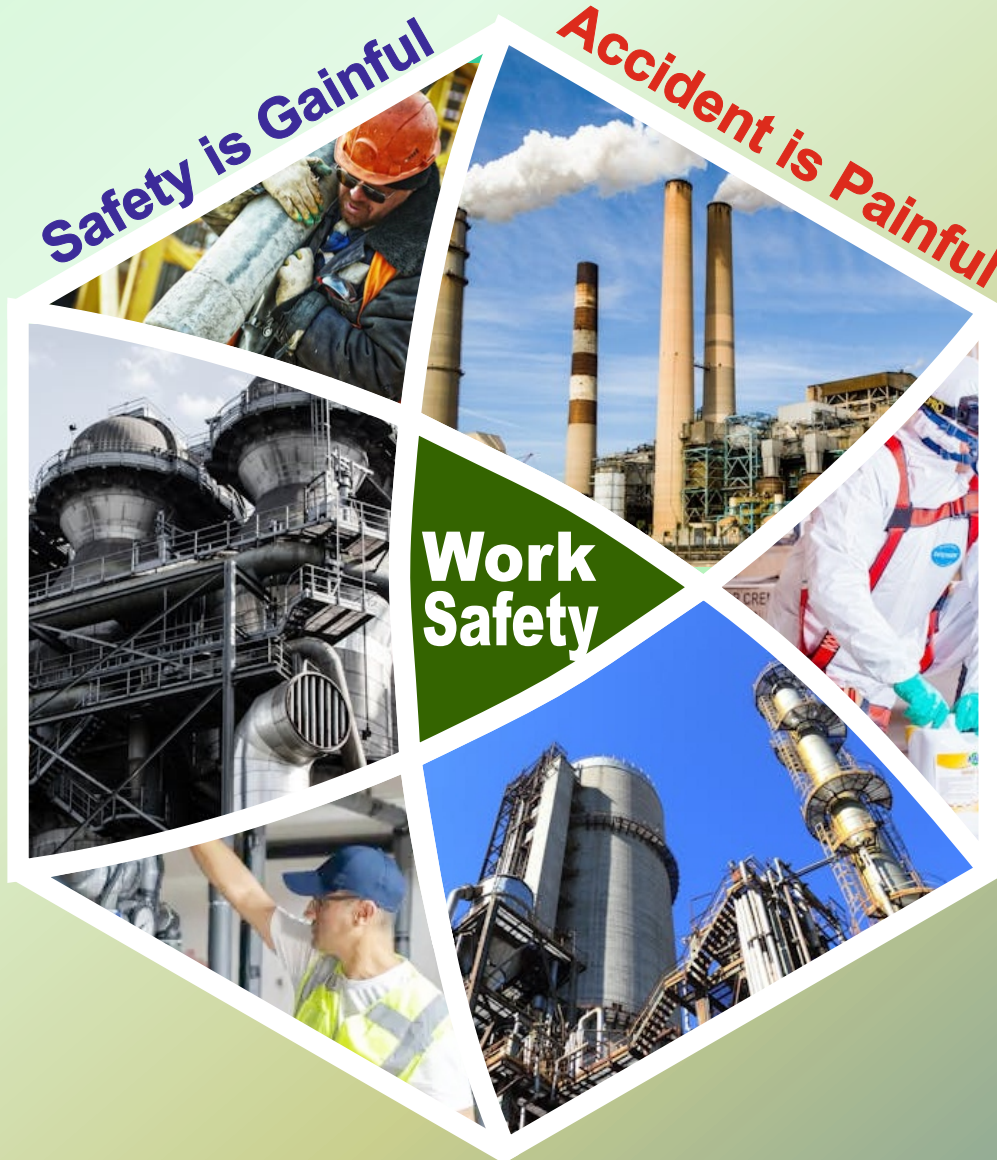

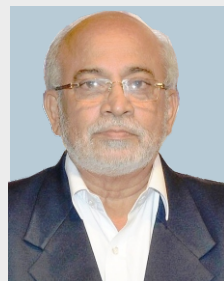

• Learning : Does innovative safety practice helps in creating a learning organisation?	10

- ⊙ Safety Case Studies may be on QC, LQC, Kaizen, 5 S & Poka Yoke in DMAIC or 12 step methodology.
- ⊙ Each case study to be submitted in soft copy only in Power point format by a separate email to qcfimc@yahoo.co.in along with the duly filled registration form.
- ⊙ Case study should not exceed 25 mb, along with needed figures and pictures
- ⊙ Case study should be submitted before 30th June 2024
